Torin Togut was a Cousins Fellow and then an adjunct professor at the University of Georgia School of Law, where he taught special education law and supervised law students in a special education practicum. For more than 25 years, Mr. Togut worked as a public interest attorney with Georgia

Legal Services Program in the area of education, disability and health law. He is now primarily engaged in the private practice of law. Mr. Togut's practice focuses on representation of families of children with disabilities, education law, employment discrimination, civil rights and criminal law. Mr. Togut is a member of the State Bar of Georgia, and the Northern, Middle and Southern District Courts of Georgia, the District Court of Vermont, the Eleventh Circuit Court of Appeals and the U.S. Supreme Court.

Mr. Togut is a frequent speaker in the areas of special education and disability law, civil rights, and federal practice at local, regional and national workshops and conferences. He has published a law review article on the School-to-Prison Pipeline and on response to intervention and specific learning disability eligibility and the child find requirements under the Individuals with Disabilities Education Act. He is the current President of the Arc of Georgia, a state wide organization advocating for the rights of persons with intellectual and developmental disabilities. He is a former President of the ACLU of Georgia. He earned his Bachelor of Science from Cornell University and his Juris Doctor from the University of Laverne College of Law.

Faya Ora Rose Toure (Sanders), Esq.





Faya Ora Rose Touré (Sanders) is a Harvardeducated civil rights activist and litigation attorney who has worked on some of the highest-profile civil rights cases in the nation. She was one of the lead attorneys on the winning legal team in Pigford vs. Veneman, which was the largest civil rights case in history. This case led to the payment of a billion dollars in damages to black farmers by

the U. S. Department of Agriculture. She was also the first African-American female judge in Alabama. Touré is the founder of the National Voting Rights Museum in Selma, Alabama, and a founding partner of the prominent civil rights law firm of Chestnut, Sanders, Sanders, Pettaway & Campbell, LLC. Intensely passionate about her activism and legal work and the needs of the black community, Touré has founded learning and cultural centers, political and legal organizations, and community initiatives that have benefited Alabamians for three decades. She uses her many talents to further her message and is a prolific songwriter and playwright, as well as the host of a weekly radio show, Faya's Fire.

She founded the Bridge Crossing Jubilee in 1985 to commemorate the Selma-to-Montgomery Civil Rights march across the Edmund Pettus Bridge, which reminds all of the importance of the Voting Rights Act that came as a result of the struggle and determination of many people in Selma and surrounding communities. She co-founded the Coalition of Alabamians Reforming Education (C.A.R.E.) in 1993 due to her desire to expose the practice of "tracking" in public schools which is a controversial system that can limit education and career opportunities. Finally, she founded the 21st Century Youth Leadership Movement in 1985. The group educates young people about the political process and encourages their involvement. It has chapters around the United States and in Mali and Senegal, West Africa.

In addition, Parks has an uncommon interest in improving the lives of the people in Africa by making both a personal and financial investment in improving the educational options found on the continent. Parks also partners with other persons of goodwill by sponsoring medical mission trips that include medical providers and supplies. Parks and his law firm are committed to meeting the legal needs of individuals and families who require attorneys who are not intimidated by the affluence or influence of the defendants. The motto of Parks and his law firm is that they stand tall for their clients and are prepared and equipped to provide quality representation for all clients as "repairers of the breach and defenders of the street." (Isaiah 58:12)
